

## KIWANIS CLUB OF HANNIBAL FOUNDATION (KCHF) RAFFLE RULES

BEFORE RECEIVING A PRIZE, EACH AND EVERY WINNER MUST ASSIST IN FILLING OUT ALL IRS FORMS, IF THEY ARE REQUIRED BY ANY FEDERAL, STATE OR LOCAL GOVERNMENT, INCLUDING BUT NOT LIMITED TO IRS FORM W-2G, AND MUST SIGN ALL IRS FORMS INCLUDING W-2G. BEFORE RECEIVING A PRIZE THE WINNER(S) MUST PROVIDE TWO FORMS OF IDENTIFICATION ONE OF WHICH MUST BE A STATE OR FEDERAL GOVERNMENT-ISSUED PICTURE ID. WINNER(S) MUST PROVIDE THEIR SOCIAL SECURITY NUMBER (OR IRS ISSUED TIN). KIWANIS CLUB OF HANNIBAL FOUNDATION (KCHF) MAY HAVE TO REPORT WINNINGS TO THE IRS ON IRS FORMS AND WITHHOLD THE LEGALLY REQUIRED PERCENT FROM THE WINNER(S)' PRIZE, OR RECEIVE A TO-BE-SPECIFIED PAYMENT FROM THE WINNER, AND TRANSMIT THE SAME TO THE IRS. KIWANIS MAY SUBTRACT THE TICKET PRICE FROM A WINNER'S TOTAL WINNINGS BEFORE AWARDING THE PRIZE. YOU MUST BE 18 YEARS OF AGE TO PURCHASE A TICKET AND WIN A PRIZE. WINNER NEED NOT BE PRESENT TO WIN, PROVIDED WINNER HAS PROVIDED TO KCHF, IN WRITING, A VALID MAILING ADDRESS AND PHONE NUMBER. A TICKET PURCHASE REFLECTS THE BUYER'S AGREEMENT TO ABIDE BY ALL TERMS OF THE RAFFLE, AND ALL CITY, COUNTY, STATE AND FEDERAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED BY LAW. WINNERS ARE RESPONSIBLE FOR DELIVERY OF THE PRIZE(S). KCHF IS NOT RESPONSIBLE FOR LOST OR STOLEN TICKETS. TICKETS ARE VOID AND WILL NOT BE HONORED IF STOLEN, UNISSUED, ILLEGALLY GENERATED, ILLEGIBLE, FORGED, MUTILATED OR ALTERED IN WHOLE OR IN PART. ANY DISHONORED CHECK OR CARD RECEIVED FOR PAYMENT OF A TICKET SHALL VOID ENTRY. THE TICKET REGISTRATION IS THE ONLY VALID RECEIPT TO CLAIM PRIZE. BY PURCHASING A TICKET, THE TICKET HOLDER AGREES TO THE USE OF THEIR NAME AND PICTURE OR LIKENESS PUBLICLY BY KCHF, IN THE NEWS MEDIA, VIA INTERNET, PRINT, RADIO OR TELEVISION, WITHOUT FURTHER NOTICE AND COMPENSATION. HOLDER OF A RAFFLE TICKET ENTRY DOES HEREBY ACKNOWLEDGE THAT MEMBERS OF THE KCHF AND THEIR FAMILIES MAY ENTER THIS RAFFLE. THE ODDS OF WINNING DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES BUT ARE NO LESS THAN ONE (PER TICKET) IN THE NUMBER OF TOTAL TICKETS SOLD. PRIZE WINNERS SHALL BE RESPONSIBLE FOR ALL APPLICABLE LOCAL, COUNTY, STATE AND FEDERAL TAXES. WINNERS AGREE TO INDEMNIFY AND HOLD HARMLESS KCHF, KIWANIS INTERNATIONAL, THEIR MEMBERS, OFFICERS, DIRECTORS, VOLUNTEERS AND AFFILIATES, AND ALL KIWANIS ORGANIZATIONS, FROM ANY AND ALL LIABILITY FOR STATE AND/OR LOCAL AND/OR FEDERAL TAXES, FEES, COSTS OR CHARGES. WINNERS MAY BE CONTACTED IN PERSON IF THEY ARE PRESENT AT THE DRAWING, OR BY TELEPHONE OR U.S. MAIL AT THE ADDRESS PROVIDED BY TICKET HOLDER. WINNERS, AFTER BEING MAILED NOTICE OF BEING A WINNER, OR BEING OTHERWISE CONTACTED BY KCHF, MUST MAKE ARRANGEMENTS TO CLAIM PRIZE WITHIN 30 DAYS OF THE DATE THE NOTICE IS MAILED OR CONTACT MADE. IF A PRIZE IS NOT CLAIMED WITHIN THAT TIME PERIOD, THERE WILL BE A REDRAWING AT A DATE AND TIME TO BE DETERMINED BY KCHF. BY PURCHASING A TICKET, YOU EXPRESSLY DISCLAIM AND RELEASE AND AGREE TO INDEMNIFY AND HOLD HARMLESS KCHF, KIWANIS INTERNATIONAL, THEIR MEMBERS, OFFICERS, DIRECTORS, VOLUNTEERS AND AFFILIATES, AND ALL KIWANIS ORGANIZATIONS FROM ANY AND ALL LIABILITY ASSOCIATED WITH CONDUCTING THE RAFFLE, INCLUDING FROM ANY NEGLIGENCE BY SAID KIWANIS PERSONS OR ENTITIES. KCHF RESERVES THE RIGHT TO CONDUCT THE DRAWINGS IN A MANNER IT DEEMS REASONABLE. THE DECISION OF KCHF SHALL BE FINAL ON ALL MATTERS CONCERNING THIS RAFFLE. KCHF RESERVES THE RIGHT TO USE ALL REASONABLE EFFORTS WITHIN THEIR DISCRETION TO VERIFY AUTHENTICITY AND THE OFFICIAL WINNERS. THE WINNING TICKETS BECOME THE EXCLUSIVE PROPERTY OF KCHF AND WILL NOT BE RETURNED. ENTRIES AND TICKETS ARE NOT TRANSFERABLE.
